

FIELDTRIP / OUTING PERMISSION FORM

My child, _____ has permission to participate in any fieldtrips/ outings planned by his/her teachers at St. Paul's Episcopal Preschool. I understand that adequate adult supervision will be provided during these fieldtrips/outings that will be within walking distance of the preschool. In the event of a fieldtrip away from the general area of the preschool, St. Paul's Preschool is allowed to transport my child in the St. Paul's school bus or I will personally provide transportation for my child to take part in the activities.

LIABILITY RELEASE

In consideration for allowing my child, _____, to participate in fieldtrips and other outings with his/her class at St. Paul's Episcopal Preschool, we/I hereby release St. Paul's Episcopal Church, all employees of St. Paul's Episcopal Church and all preschool volunteers who participate in the activities of the trips (directly related, as well as ancillary thereto), from liability on my behalf and on behalf of my minor child, based on a claim of negligence arising in any way from my child's participation in the trips and the activities which take place during the trips (*i.e.*, all activities of whatever nature from the time my child leaves my care, custody and control in anticipation of the departure of the trips until the time my child is returned to my care, custody and control after the termination of the trips) except to the extent the injury is covered by any insurance procured by St. Paul's Episcopal Church, which insurance does not allow for subrogation of the claim as against the church employees or volunteers alleged to have been negligent or to the extent and amount the injury is specifically covered by insurance providing coverage for the person or persons alleged to have been negligent. This release relates solely to ordinary negligence and does not apply to willful or wanton negligence or intentional misconduct on behalf of any employee or volunteer.

Additionally, we/I specifically agree to indemnify and hold harmless, St. Paul's Episcopal Church and any church employee or preschool volunteer who participates in any aspect of the trips from any loss, damage, or demand sustained in any way related to my child's participation in the above designated trips whether from their alleged negligence or otherwise, except with respect to the individual employee or volunteer where the loss relates to willful or wanton negligence or willful misconduct of that church employee or volunteer.

This release and indemnity as to St. Paul's Episcopal Church is absolute to the extent not covered by insurance.

The fieldtrip/outing permission form and release form **must be signed by both parents or guardians**. In the case of divorce, the parent with primary custody of the minor child must sign; joint custody requires both signatures. The forms must be on file in the St. Paul's Preschool office prior to the beginning of school in September. If either or both parents(s) refuse to sign these documents, the child may participate in fieldtrips/outings only if the parent accompanies the group. If the parent is unwilling or unable to accompany the child, the child may not attend preschool on days when fieldtrips/outings are scheduled. Advance notice of such trips will be given.
